

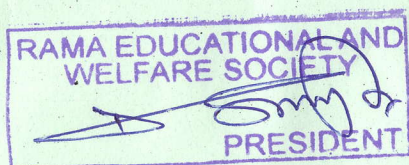

The Government of Madhya Pradesh, through the State Education Officer, Bhopal, is pleased to inform that the Government has decided to grant the following facilities to the teachers of the Government schools and colleges under the Madhya Pradesh Society, Registered under the Societies Registration Act, 1860 (Act No. 21 of 1860) and the Societies Registration Act, 1909 (Act No. 21 of 1909) as follows:

1. That the Government will provide a community service and not as a private and that community service should be given in the school in any manner whatsoever.
2. That no part of income from the land which is being and will be donated to any individual in the Madhya Pradesh Society (School) shall be made available to any other person.
3. The savings, if any, after meeting the expenses and other charges, shall be further utilized for providing the facilities and other facilities in the interest of education in the same school only.
4. That school is not paying any subscription or other charges to any other organization or body.

6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
- 7- That the principal and Correspondent/manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land .
8. That the school will ensure compliance of all statutory requirements like EPF, ESI, and Labour Laws etc, with respect to the school and staff of the school.
9. That the school will ensure that the Building Safety, Fire Safety, Water Safety Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
10. That the school will ensure that all required infrastructure is available with the school. before starting classed.
11. That the school will ensure that sufficient number of qualified teacher as per the provisions contained in affiliation bye-laws are available with the school before starting classes.
- 12- That the school will follows the provisions related to fee contained in affiliation byelaws and will disclose the details of the fee to the students /parents every year before start of session without resorting to any hidden charges in the heads of the fee.
13. That the school will not coerce any student /parent to buy books/stationary/ uniform .
14. That the school shall strive to make efforts for conservation of environment.
15. That the school will ensure that the school fulfills all essential requiremet before applying for affiliation and will fulfill all other conditions post affiliation and comply with all the general rules as given in the affiliation byelaws or notified from time to time.
16. That in case affiliation has been with certain conditions, the school will not start CBSE pattern classes without submitting a certificate/affidavit to the effect that
